Report from the Legislative Committee



"A man works from sun to sun, but a woman's work is never done." This old saying aptly describes the work of the men and women in VRTA since our October meeting. Our members studied and became better informed on the issues and probably worked harder than they ever have as they met with and contacted legislators by phone, emails, and letters.

VRTA members spoke at all five of the budget hearings held around the state in January.

Bonnie Atwood, our lobbyist, worked tirelessly to support units and districts in their lobbying efforts. Also, she testified before numerous committees on our issues and represented us in meetings with other groups that have positions similar to ours. Jason Winter, our webmaster, posted information on the VRTA website to provide facts and statistics useful to us in lobbying. I tried to keep the membership informed by almost daily

emailed legislative updates during the General Assembly session, and the members responded by using the information to make legislative contacts.

VRTA joined the Virginia Pension Coalition in order to partner with other groups to save the defined benefit retirement plan. We participated with this coalition in a tele-press conference and a tele-townhall to publicize information about retirement to both the public and our members across the state.

Make no mistake about it, there is a concerted, nationwide effort to destroy public education under the guise of reform and improving education. VRTA is working hard to preserve public education, the backbone of our society for two centuries. It is sad that more effort must be expended to save it than to improve it.

I encourage you to come to the spring Delegate Assembly in Blackstone April 23-24. Again this year, the VRS staff will make a presentation to the entire assembly. Since this article is being written just after crossover, legislation is far from finalized. In the Legislative Workshop on Monday, April 23, we will analyze the 2012 General Assembly session and begin our work for 2013. Successful advocacy depends on the preparation, strength, and continuous efforts on the grass roots level in each locality. All teachers know that our work is never done.

VRTA Update From the Treasurer

Thanks to all for your cooperation during 2011-2012. The membership rosters will be available at the 2012 Spring Meeting for review by each unit. If your unit will not have a representative present, please have someone from your district pick up your roster. This process helps to keep our membership current. However, you may notify me at any time of a deceased member. For units with newly elected treasurers, please free to contact the State Treasurer if you have questions about submitting dues, the IRS Group Tax Exemption, or need Membership Enrollment Forms or Dues Settlement Statement Forms.

Each District and Unit listed by the IRS as subordinates of the VRTA Umbrella for tax exempt status is reminded to file with the IRS for the year ending June 30 by November 15. The VRTA Group Exemption Number is <u>5658</u>. This number must be included along with the individual EIN on the return of each district or unit included in the Group Exemption of VRTA.

A reminder to all districts and units that are approved as a part of the VRTA Group Tax Exemption for IRS, that documentation must be on file with the State Treasurer to continue to be a part of the VRTA Group Tax Exemption Plan under section 501 c 4 of the Code. The documentation includes: Constitution/Bylaws signed by two officers and the date approved or amended, the current budget (2011-2012) signed by two officers the date approved, and the Policy Statement signed by two officers and dated when approved (if not already submitted). If your district or unit has not submitted this documentation, do so immediately or it may be too late.

Four units have requested to be added to the list for approval on the IRS Report that will be submitted March 2012. Three units have completed documentation and one still has to submit materials. This will make a total of 81 districts and units approved.

Report from the Virginia General Assembly

Politics has always been a rough and tumble world. Those who would make, execute, and enforce our laws are generally well educated, gentlemanly or ladylike (for the most part), and gifted in verbal and social skills. But, in spite of that civilized demeanor, they can sure pack a punch.

They've been packing punches pretty hard for retirees and educators the last couple of years. Without getting into the many technicalities right now, let's take an overview of just a few of this year's bills affecting teachers (note this was written in February, so some points may be outdated when you read this):

- **Hybrid retirement** plans: I think these are designed to try to make everybody happy, but they don't. This year's proposal would create a new hybrid program, administered by VRS, with components of both DB and DC. New state employees (commencing after 2014) would make an irrevocable election to participate in hybrid or traditional. Employees in service at the end of 2013 would have the opportunity for a one-time irrevocable election of hybrid.
- **Reduced retirement** plans: "Reduced" is a relative term, and some proposals don't call themselves reductions, but that's what they are. If a retiree is required to pay more money into the system, then the money in his pocket is reduced—whether the bill proponents call it that or not.
- **Teachers' contracts**: This was a nail-biter, and as I write this, it's not over. The Senate defeated a Senate bill (promoted by the governor), which would phase out the current employment system in favor of a three-year contract plan, which would make it a lot easier to dismiss teachers. The vote was rather close. The House version did cross over to the Senate, so we'll see what happens.
- Tax credits for scholarships for private schools: A Senate Bill and a House Bill with innocuous sounding language are making their way through both sides of the Capitol. They would establish tax credits to corporations who provide scholarships to students who attend private schools. What's wrong with that? It takes away our resolve, not to mention our financing, to make public schools good, better and great.
- **Health credits:** We had legislators from both House and Senate introduce bills that would help, through health credits, our personnel who are not necessarily teachers. Both got left in committee.

Bad news notwithstanding, the good news is that teachers and other labor groups are fighting back.

This is the year to be unified, strong, and confident. It's hard for me even to imagine a teacher needing to be told such a thing. Teachers still stand out as models for me, as orators, as community-minded, and as exemplary citizens. Keep it going!

On a personal note, thank you to all who expressed sympathy for the death of my mother. She was a wonderful person. She was not a professional teacher as you are, but as a mother, she was a "teacher" to me. And she possessed all these qualities that I so much admire.

News from Around the Commonwealth

District M Creates Banner

In spring 2011 the District M Retired Teachers Association asked each local unit to contribute a quilt square for the district banner. Mrs. Effie Brown, retired from Floyd County Schools, volunteered to create the Floyd County square. Mrs. Brown has been a member of the RTA since 1974.

Mrs. Brown created the pattern for the square, which was called "Little Red School House." The pattern originated in either New Hampshire or Vermont in the 1890s. After an attempt to create the square and finding the red dye in the fabric bled onto the white, she enlisted the help of Judy Blackwell, a local historian to help finish the work. The "Little Red School House" is



now the center block for the District M RTA banner.

Effie Brown, who recently celebrated her 101st birthday, is known for her hand sewn quilts. She has donated close to 30 sample quilt squares, along with the stories behind them, to the Floyd community through the Old Church Gallery, located on Wilson Street in Floyd.

Commonwealth of Virginia Budget Meetings

(Jim Bradford made the following report at the Lexington budget hearing of the Committee of Budget and Finance.)

My name is Jim Bradford, an officer (president-elect) in the Virginia Retired Teachers Association with 6900 plus members from 83 local retired teacher associations in Virginia. It is to be noted the VRS average annual teacher benefit is \$20,814. It is to be noted that 34% of the payment for this benefit comes from employer/employee contributions and 66% comes from the VRS investment of these funds.

The VRTA Legislative Priorities for 2012 are:

- The VRTA supports the inclusion of the State Health-Credit Benefit Plan for school support personnel. This legislation passed the House of Representatives last year.
- The VRTA supports the present VRS Defined-Benefit Plan over the Defined-Contribution Plan. Research supports the Defined-Benefit Plan as the less expensive of the two plans to the state.
- The VRTA supports state programs that encourage persons to enter the teaching profession as a career. Let's give these professionals the freedom to teach.
- The VRTA opposes additional legislation that increases the financial burdens on the local jurisdictions. Balancing the state budget has been at the expense of the localities. This has been a back door approach that has increased local property taxes in many jurisdictions.

Free Tax Assistance Available

It's tax time, and that means it's time to gather your tax documents and prepare your forms and send them to the IRS. For those of you who would rather someone else prepare your taxes for you, AARP Foundation Tax-Aide is available at 6,100 sites around the country in every state in the nation. Founded more than 40 years ago by volunteers, AARP Foundation Tax-Aide now has 35,000 volunteers, many of them retired teachers! Volunteers are trained by AARP Foundation Tax-Aide and certified by the IRS and have to pass a test to show their competence each year. If you or someone you know has a low to moderate income - no matter what age you are invited to find a site near you at www.aarp.org/ taxaide . Tax-Aide can even e-file your return, resulting in a quicker refund. The filing deadline this year is April 17.

In 2010-2011 thirteen units in Virginia submitted With Our Youth reports. Seven of those reports were sent to NRTA to be judged among those throughout the country for the national excellence award.

A total of 20,813 hours were volunteered serving a total of 22,268 youth in Virginia. The estimated dollar value of volunteer time in Virginia in 2010 was \$458,510.

Those units submitting With Our Youth reports were Amelia, Brunswick County, Charlotte County, Chesapeake, Colonial Heights, Dinwiddie, Franklin/Southampton, Lunenburg/Nottoway, Patrick County, Petersburg/Prince George, Rockbridge, Shenandoah County, and Suffolk.

Brunswick County RTA received the NRTA National Excellence Award for work with youth. Rebecca Villarreal said in the press release, "The Brunswick County Retired Teachers Association is highly involved in the daily operation of the Brunswick County Mayfield Recreation Center. This center provides a much needed place for recreation for underserved black youth with approximately 3,000 youth served per year. Members from the association provide 4,000 volunteer hours through a variety of activities which include operating the center; keeping the playground, pool, and buildings safe and clean; providing a full-time day care; and assisting with fundraising."

Along with the Brunswick County Retired Teachers Association, the Virginia Retired Teachers Association was also a recipient of this year's NRTA With Our Youth Dedication Award. Both Brunswick County and the state of Virginia were chosen for their service to youth by an independent selection panel.

In a press release, Megan Hookey, vice president of NRTA said, "Retired educators and school personnel are unsung heroes in their communities. They continue to give of their time and expertise even after leaving the classroom. It is an honor to celebrate the skills, passion, and commitment of the members of the Virginia Retired Teachers Association and the Brunswick County Retired Teachers Association with NRTA With Our Youth Dedication Awards."

Community Service Recognition – Fall 2011

Seventeen units submitted Community Service reports, and all of them were "most active units." The units were Amelia, Augusta, Charlotte County, Chesapeake, Colonial Heights, Dinwiddie, Fauquier, Franklin/Southampton, Greensville, Lunenburg/ Nottaway, Patrick County, Petersburg/Prince George, Rockbridge, Suffolk, Warren County, Winchester, and Wythe County.

A total of 67,028 hours were given to community service by Virginia's retired teachers. A dollar value of that volunteer time amounted to \$1,476,626.80. Based on community service volunteer hours the Charlotte County Retired Teachers Association was the Most Active Unit Award winner.

VRTA Insurance Committee

The VRTA Insurance Committee has announced that the contract for our Agent of Record, John Jones, has been extended for an additional five year period by unanimous vote of the VRTA Board of Directors at the May 9th Blackstone meeting. During the evening of April 23rd at the VRTA Delegate Assembly in Blackstone, Ricky Cox will entertain. He teaches Appalachian folklore, American literature, and an introductory course in Appalachian studies at Radford Uni-

versity. As an associate of Radford University's Appalachian Regional and Rural Studies Center, he coordinates the Farm at Selu, a living history site representing 1930s farm life in Southwestern Virginia.

Cox earned an Associate in Applied Science degree in machine technology from New River Community College and a BA in history and a MA in English from Radford University. He was a contributor to the *Encyclopedia of Appalachia*: *An Introduction to the Region* (University of Tennessee Press, 1996), with Grace Toney Edwards and JoAnn Asbury. Cox co-authored The Water-Powered Grist Mills of Floyd County Virginia: Illustrated Histories 1770-2010 with the late Frank Webb.

On April 23rd Ricky Cox will present a program of traditional Appalachian music for the VRTA. He will combine lecture and performance, accompanied by guitar and oldtime banjo. Ballads and lyrical folk songs will be included in his performance. This will be a highlight of the VRTA Delegate Assembly.
