

Education is still front and center in the attention of the Virginia Executive Branch, judging by an initiative by Governor Ralph Northam that was announced last April. "Virginia is for Learners" includes a number of key components to help support and prepare students for success. Here is a summary:

- A Stronger Focus on Deeper Learning: critical thinking, creative thinking, and communication, are a few
- New High School Graduation Requirements and Career Pathways: Looking closely at what students need for life AFTER
  school
- Modernizing the Virginia Standards of Learning: New testing approaches
- More and better early childhood education: Virginia supports birth to five programming
- New Standards of Accreditation: New emphasis on real-world skills
- Maximizing the potential of all students: Focusing on the changing needs of a diverse student population

This initiative is supported by the Department of Education, the Board of Education, Jobs for the Future, and the PTA.

#### Focus on Awards

To win awards is easy, yet because of our growth the questions arises, "How do you win awards?" Review this article and do what it suggests.

The deadline for reporting is June 30<sup>th</sup> of each year.

- Units and districts must report by the deadline to receive the most awards.
- The first ten units reporting receive the Early Bird Award.
- Unit and district banners must be displayed at the fall and spring VRTA meetings each year.
- Districts with 100% of their units' banners displayed receive an award.
- Awards are given to districts and units giving scholarships, no matter what the amount.
- If all the units in a district give a scholarship, the district receives an award.
- Awards are given to units with equalized membership in the unit, district and state.
- The district will receive an award if all units in the district have equalized membership.
- A special award is given yearly by the Awards Committee.

Reminder: Banners are checked on Tuesday between the hours of 12:00 PM and 4:30 PM.

We strongly encourage participation. Let's improve.

Local unit treasurers have an important, critical job to do in helping to maintain and increase membership in VRTA. Your encouragement to your local members to remain or become a member of VRTA is very important and I thank each of you for the hard work you do in soliciting VRTA memberships and keeping accurate records for your local units. The deadline for filing is November 15 annually and you must file the e-post card in order to maintain your tax exempt status. In addition, please submit a copy of your approved budgets for 2019-2020, signed and dated by two officers prior to the deadline of December 31, 2019. We are required by the IRS to keep these on file in case of auditing.

Thank you, local treasurers, for continuing to update me on VRTA membership changes, especially address changes and names of deceased members. Please keep up the good work.

As you are collecting dues, don't forget to distribute a VRTA membership card to each of your new or renewing members. A supply of cards was distributed to local unit treasurers at the spring meeting but I will have some extras on hand in Richmond if they are needed. These cards are to be issued annually, but only to members who pay their \$20 VRTA dues. Life membership cards will continue to be issued by the state treasurer and are issued only one time. #### Loudoun Retired Educators Have a Busy Year

The Loudoun Retired Educators have been busy this year. In July volunteers worked with others in the Kids are First organization to assembly 29 school supply items to 30,000 students in 90 schools of Fairfax and Loudoun counties.

In September nine volunteers collected over 1,000 pounds of non-perishable food items for Loudoun Hunger Relief at two local grocery stores.

In October over 20 LREA members joined others at the annual Inova Hospital Rummage sale. Donated items were sold by our volunteers in the linen and book departments. More than 10,000 books were sorted and sold providing \$10,000 for the hospital. We also held a silent auction at our monthly meeting. Designed to help raise money for our scholarships, we raised \$1,000 with handmade items that were crafted or baked by our members.

In November sixty LRTA members contributed food items and Giant cards to create 15 complete turkey dinners for our local pantry. This included a \$10 card for turkey, stuffing, gravy, potatoes, vegetables, cranberry sauce and desserts.

In December LREA volunteers brought wrapped Christmas presents for the clients of Mobile Hope, which helps at risk young and adult clients.

In April we read 41 applications for our four \$1,000 scholarships to be given in June at the end of year awards ceremonies. Twelve volunteers helped with this activity.

Every Tuesday during the year, LREA members have met to assemble weekend food bags for Loudoun County students as part of an outreach program of the Loudoun Education Association. Youths that are assisted vary from 1133 to 1339 a week. Twenty-eight LREA volunteers help make this happen.

In addition to these activities, we have donated an average of \$1000 in money and food supplies each month at our regular meetings and contributed to the District N Community Service projects.




#### **Gloucester Retired Educator Association**

#### Dr. Rosa Atkins — Keynote Speaker



Dr. Rosa Atkins, Superintendent of Charlottesville City Schools, will be the keynote speaker at the VRTA's Fall 2019 Meeting. Charlottesville City Schools serves economically, ethnically, and racially diverse students in nine schools. During Dr. Atkins' tenure, Charlottesville City Schools has become one of the top performing school divisions in the state with an on time graduation rate of 93% and one of the best Advanced Placement programs in the area. In 2011, she was named Virginia Superintendent of the Year by the Virginia Association of School Superintendents, as well as Virginia State University Alumna of the Year for Professional Education.

In 2015-16, she served as President of the Virginia Association of School Superintendents. Under her leadership, Charlottesville schools have been marked by innovation and collaboration. The creation of advanced manufacturing and engineering labs at Buford Middle School and Charlottesville High School – as well as new cur-

ricula and engineering pathways – have been made possible by a partnership with area businesses, school divisions, and the University of Virginia. Because of this commitment to innovation, Dr. Atkins was recognized by the U.S. Department of Education as one of 100 Future Ready Superintendents in 2014 and invited to the American Association of School Administrators' Digital Consortium at the White House.

In October 2016, Dr. Atkins was named as one of two national finalists for the Women in School Leadership Award for Superintendents, presented annually by the School Superintendents Association (AASA) in cooperation with the Bill & Melinda Gates Foundation. She is the President for the Urban Superintendents Association of America. In June 2017, Governor McAuliffe appointed Dr. Atkins to the State Council of Higher Education for Virginia (SCHEV). Dr. Atkins demonstrates her commitment to developing future leaders by serving as an Executive Board member and mentor for aspiring superintendents for AASA/Howard University Superintendents Academy. Dr. Atkins is an alumna of Virginia State University and Virginia Tech.
