



84% of VRS retirees remain in Virginia (as of 6/30/24)










2025 Budget Amendments

Bill NumberDescriptionItem 74
#2cDHRM's biennial report on employee compensation shall include an
evaluation of total compensation, including retirement benefits, for VaLORS
members.DHRM and VRS will analyze if elimination of the defined benefit plan has
affected recruitment and retention of state employees.DHRM will solicit separately from VRS an assessment of whether the
elimination of the defined benefit plan has affected recruitment and
retention of teachers.

Historical Funded Status - Actuarial Value of Assets up to 2013 & Market Value of Assets 2014 Forward


Projected Funded Status using Market Value of Assets (New GASB Standard)

2025 Cost-of-Living Adjustment (COLA)



2.48% Plan 2 & Hybrid COLA

The increase was included in the August 1 benefit payment of eligible retirees.

The Code of Virginia :

- Requires VRS to determine the COLA annually.
- Sets the method for the calculation and caps the annual COLA for retirees at:
 - a **3% maximum** for Plan 2 and Hybrid Retirement Plan members
 - a **5% maximum** for Plan 1 members



Group Life Insurance Minimum



The Group Life Insurance Program minimum benefit for members retired with at least 30 years of service will be increased to **\$9,768,** effective July 1, 2025.



VRS Fund Value




Fiscal Year

Investment Diversification



VRS uses stocks, bonds, real estate, cash and other investment strategies to diversify the fund portfolio.

Diversification

- Combines different investments to limit exposure to a single asset or strategy, lowering risk or exposure to a single investment.
- Creates a stable foundation that serves to moderate the impacts of market conditions.
- Follows the mandate of the Code of Virginia (§ 51.1-124.30(C)), helping prevent frequent shifts in participating employers' contribution rates and providing rate consistency from year to year.







Health Insurance Credit



- Provides a reimbursement to assist with the cost of individual health insurance premiums
- Dollar amount set by the General Assembly
- Current maximum payable is \$4/year of service

To be eligible you must:


- Retire from an eligible employer
